# **MODE OF MEETING**

As a precautionary measure to curb the spread of the Coronavirus disease ("COVID-19"), the Company will continue to leverage on technology for the conduct of a virtual AGM in line with Note 1.2 of the revised "Guidance and FAQs on the Conduct of General Meetings for Listed Issuer" issued by the Securities Commission Malaysia on 16 July 2021. The Company wishes to facilitate communication and engagement with shareholders by conducting the 29th AGM on a virtual basis through live streaming and online remote voting.

# **REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES**

Members are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 29<sup>th</sup> Annual General Meeting ("29<sup>th</sup> AGM" or "AGM") of Apollo Food Holdings Berhad ("Apollo" or the "Company") using RPV Facilities provided by Tricor Investor & Issuing House Services Sdn Bhd (the "Share Registrar" or "Tricor" or "TIIH") via its **TIIH Online** website at https://tiih.online.

Members who appoint proxies to participate via RPV Facilities in the 29<sup>th</sup> AGM must ensure that the duly executed Form of Proxy are deposited in a hard copy form to the Share Registrar's Office or by electronic lodgement to Tricor no later than **Sunday**, **15 October 2023** at **9.00 a.m.** 

Corporate representatives of corporate members must deposit their **original or duly certified** certificate of appointment of corporate representative to the Share Registrar's Office not later than **Sunday**, **15 October 2023** at **9.00 a.m.** in order to participate the 29<sup>th</sup> AGM via RPV Facilities.

Attorneys appointed by power of attorney are to deposit their power of attorney with the Share Registrar's Office not later than **Sunday**, **15 October 2023** at **9.00 a.m.** in order to participate the 29<sup>th</sup> AGM via RPV Facilities.

A member who has appointed a proxy or attorney or authorised representative to participate at this 29<sup>th</sup> AGM via RPV Facilities must request his/her proxy or attorney or authorised representative to register himself/herself for RPV at TIIH Online website at https://tiih.online.

As the 29<sup>th</sup> AGM of Apollo Food Holdings Berhad is a fully virtual 29<sup>th</sup> AGM, members who are unable to participate in this 29<sup>th</sup> AGM may appoint the Chaiman of the meeting as his/her proxy and indicate the voting instructions in the Form of Proxy.

- 1. Should your registration for RPV be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.

## **ENTITLEMENT TO PARTICIPATE / GENERAL MEETING RECORD OF DEPOSITORS ("ROD")**

Only a depositor whose name appears on the ROD as at **09 October 2023** shall be entitled to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 29<sup>th</sup> AGM or appoint proxies/corporate representatives/attorneys to participate remotely on their behalf.

### APPOINTMENT OF PROXY / CORPORATE REPRESENTATIVES / ATTORNEYS

The 29<sup>th</sup> AGM will be conducted in a fully virtual basis via TIIH Online Platform, if you are unable to participate the meeting via RPV on 17 October 2023, you may appoint the Chairman of the meeting as proxy and indicate the voting instructions in the Form of Proxy.

Accordingly, Form of Proxy and/or document relating to the appointment of proxy/corporate representative/attorney for the 29<sup>th</sup> AGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than **Sunday**, **15 October 2023** at **9.00 a.m.**:

The Voting at the 29<sup>th</sup> AGM will be conducted by poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad Main Market Listing Requirements.

Members can proceed to vote on the resolutions at any time from the commencement of the 29<sup>th</sup> AGM at 09.00 a.m. but before the end of the voting session which will be announced by the Chairman of the Meeting. Kindly refer to the note above, "Procedures for RPV Facilities" for guidance on how to vote remotely from **TIIH Online** website at https://tiih.online.

Upon completion of the voting session for the 29<sup>th</sup> AGM, the Scrutineers will verify the poll results followed by the Chairman to declare whether the resolutions are duly passed.
